Launch of Temporary Use Cloud Connection Service (Tokyo Location) Utilizing the BroadLine Cloud Connection Solution

Enriching the temporary use service lineup to respond to customer needs in data transfer and testing

On October 27, 2016, TOKAI Communications Corporation (President & CEO: Katsuhiko Tokita; hereinafter the "Company") will begin providing the "Temporary Use Cloud Connection Service," utilizing the BroadLine "Cloud Connection Solution" for carriers and corporations, from its Tokyo location.

The BroadLine "Cloud Connection Solution" is in use by many customers as a high quality, broadband service that connects customer locations with major cloud services, including Amazon Web Services (hereinafter "AWS").

The "Temporary Use Cloud Connection Service" is a service that provides this Cloud Connection Solution on a per-day basis at service locations designated by the Company. Customers may use this service for only as many days as needed, utilizing a closed network connection for various uses such as connection testing and high volume data transfer to cloud-based customer environments.

In addition to the Shizuoka location, which has been providing this Temporary Use Cloud Connection Service since January 2015, the Company will launch the service at the Tokyo location as well. As a result, the Company will gain the ability to provide this service to a greater number of customers who currently use corresponding cloud services or are considering using such services.

As a partner company to various cloud service operators, the Company will work toward providing highly reliable and stable connection environments while promoting the development and provision of various services to support customers' cloud usage in the future.

1. Service overview

By utilizing the BroadLine Cloud Connection Solution, the service will provide customers with connections to their cloud environments from the service locations designated by the Company on a per-day basis. The Company will provide connections (including connection manuals and router settings for connections) to cloud services specified by customers. Customers will need to bring personal computer devices and data for transfer (data saved on portable disks, etc.) on their own upon use.

Per-day basis (Usage fees will also apply on a per-day basis, and charged based on the number of days of use, regardless of the number of hours used.)


